Over 3.6 Million Californians Face AHCA Cuts That Their Own Congress Members Voted For: Data by District

Over five million Californians rely on direct help through the Affordable Care Act, either to get their coverage through the Medicaid (Medi-Cal) expansion, or to get financial assistance to afford a private health plan through Covered California. Over 1.2 million Californians who receive these direct benefits live in districts where their congress member voted for the American Health Care Act (AHCA) which would cut these benefits. When including the broader cut to Medi-Cal, over 3.6 million residents in these districts would face cuts to their care.
